### **BUILDING DEPARTMENT:**

- Issues permits for new construction, additions, pools and fences.
- Plans for building additions, decks, pools, and fences must be reviewed by the Architectural Board that consists
  of three professional architects.
- Maintains records of house plans on microfilm (since 1970) and maintains plat books for the City.
- · Retains list of various contractors, landscapers, and snow plowers licensed to work in Pepper Pike.
- Preserves the City's housing standards by strictly adhering to an exacting and critical list of inspections for new homes and for any additions.
- Systematically checks all existing homes to ascertain they, are being maintained in accordance with the high standards of
  quality for which Pepper Pike is known.

# CITY ENGINEER:

The City Engineer is responsible for:

- Reviewing development plans, grading, and drainage plans for proposed new houses.
- Guiding the City in the development and upkeep of its infrastructure.
- · Overseeing municipal improvement projects and working with other governmental agencies on the City's behalf.
- Preparing grant applications in an attempt to bring State and Federal funds to the City.
- · Meeting with residents concerning engineering problems.
- Consulting with builders and developers concerning the availability of existing utilities and resources.

## FINANCE DEPARTMENT:

- · Maintaining accurate accounting of all receipts and expenditures for the City.
- Prudently investing available funds to maintain absolute safety of principal and at the same time maximizing investment returns.
- Prepare annual budgets for the Police, Fire, Service, and administrative departments of the City.
- Prepare monthly and annual financial reports reflecting all monetary activities.
- Current property tax rates are:
  - Orange School District 79.34 mills Current income tax rate is 1% with a 50% tax credit on income taxes paid to other communities (credit limit 1%).

### FIRE DEPARTMENT:

- Around the clock advanced life support paramedic service with two fully equipped paramedic rescue squads.
- Rapid response to emergencies averaging five minutes.
- Dedicated staff of full and part-time personnel on duty around the clock, all of whom are State Certified Paramedics.
- Fire insurance rating of 5
- · Digital recording of all phone and radio traffic.
- Well organized and effective interdepartmental mutual aid system, including Tech Rescue Team, Rapid Intervention
  Team, Underwater Dive/Recovery Team, Mutual Aid Box Alarm System (MABAS), and Interdivisional MABAS System
  with Lake, Geauga, Summit and Cuyahoga Counties.
- · Effective public elementary education program.

### LEGAL DEPARTMENT:

The City's Law Director, Mr. Stephen Byron, attends the Planning & Zoning Commission and all Council meetings. The City's Prosecutor is Mr. Jonathan Greenberg.

#### POLICE DEPARTMENT:

- Consists of 15 full-time officers with a response time averaging between two to three minutes on high priority calls.
- Each patrol car is equipped with an automated external defibrillator.
- CodeRed emergency communication system.
- Operates under the belief that enforcing the law and treating people with respect are not mutually exclusive.
- Patrols every street at least once every eight hours.

#### SERVICE DEPARTMENT:

- Back door rubbish pickup and active recycling program.
- Prompt and efficient snow removal.
- Personal response to requests for service from residents.
- Mailbox installation in the amount of \$125.00 for Step II design mailbox.
- · Active road repair and storm sewer maintenance programs.
- Sign maintenance.
- Landscape and maintain all City properties.
